#### **CHAIN OF RESPONSIBILITY POLICY:**

TFP Box notes the profound demands for the market that uses forestry products.

Predicting that these challenges will increase to the point of becoming, in the future, critical factors in the competitiveness between companies, TFP Box invests in innovation, sustainability, product and service quality, by committing to safety, health and conditions of employees, compliance with the requirements that allow customer satisfaction and loyalty, collaborating upstream with its suppliers and downstream with its customers, so that the Chain of Responsibility and Custody can be ensured until the end customer.

TFP Box is committed to complying with the requirements, and continuously improving the effectiveness of the Quality Management System implemented.

TFP Box is committed to the values of the Chain of Responsibility, by signing a self-declaration about not being directly or indirectly involved in the following activities:

- a) Illegal logging or trade in wood or forest products;
- b) Violation of traditional rights and human rights in forestry operations;
- c) Destruction of high conservation values in forestry operations;
- d) Substantial conversion of forests into plantations or non-forest use;
- e) Introduction of genetically modified organisms into forestry operations;
- f) Violation of any of the fundamental ILO conventions, as defined in the ILO Declaration on Fundamental Principles and Rights at Work.

TFP Box is committed to complying with the requirements of the fundamental conventions of the International Labour Organization (ILO), namely the fundamental labour requirements related to:

- . Effective abolition of child labor;
- . Elimination of any and all forms of forced or compulsory labor;
- . Discrimination in matters of employment and profession;
- . Freedom of association and effective recognition of the right to collective bargaining.
